Citizenship by Investment

Fee schedule

The Citizenship-by-Investment program of Antigua and Barbuda, grants immediate passport to investors who make a significant economic contribution to the country, under the following 3 options:

The Government is offering Limited Time Offer (LTO) only until early 2014, after that the passport fees will be increased.

- A contribution to the National Development Fund (NDF) in the amount of **US\$ 200,000** (exclusive of government and due diligence fees)
- The acquisition of real estate with a minimum value of **US\$ 400,000** (exclusive of government and due diligence fees)
- The investment in an approved business of at least **US\$ 1,500,000** for a single applicant or jointly by 2 persons or more totaling at least US\$ 5,000,000 and where each individual contribution is a minimum of US\$ 400,000 (exclusive of government and due diligence fees)

The passport will be issued for a **5-year term** and, in order to renew it, each new citizen **must spend at least 35 days** in Antigua & Barbuda during the initial 5-year period. The 35 days can run consecutively or can be spread over the 5-year period, to be evidenced through their entry and exit stamps within their passport.

NDF Fees

The National Donation Fund (NDF) contribution is a quick and efficient way of gaining citizenship in Antigua & Barbuda and this **Limited Time Offer (LTO)**
